Goddard awards two graduates

Two Parkinson Memorial School graduates have been rewarded for their hard work and dedication.

During the school's recent graduation ceremony, Shacoria Alleyne and Imani Hinds were presented with Awards of Excellence from Goddard Enterprises Ltd (GEL).

Alleyne is a multiple recipient of the Principal's Academic Award and epitomises dedication and excellence. Since becoming a pupil of Parkinson Memorial School, she consistently ranked among the top three in her class and remains in the top percentile of her entire year group.

Inspirational leader

Hinds was described as an inspiration whose introduction to secondary school was marred by the COVID-19 pandemic, which required schools to shift to an online learning environment.

However, his curious mind and steadfast dedication quickly overcame

the transition and even after the school returned to face-to-face instruction, he was the first to submit assignments and was always punctual for classes. His determination and dedication led to him being entered for six CSEC subjects, including English, Mathematics and Social Studies. His selection to the role of a prefect was predicted, and he carried out his duties with pride. Hinds' journey is a compelling testimony of resilience, commitment and an unyielding spirit.

Achievements

Head Office People Co-ordinator, Valerie Lovell, presented the award.

Lovell congratulated the two inspiring young people for their overall achievements.

She added that their courage, determination and leadership skills made them positive role models at their school, noting these qualities were reflective of the company's core values. She wished them well as they moved on from secondary school.

Since adopting the school in 2018, the company has hosted students at its Haggatt Hall, St Michael, head office on successive international men's and women's days, where some senior executives engaged them in interactive and informative sessions.
